
The University Grants Commission (UGC) notifies Regulations regarding the maintenance of standards of higher education in the country. In some of the UGC Regulations, grades/scores obtained in NAAC accreditation are taken as criteria to make Higher Education Institutions (HEIs) eligible for certain privileges/entitlements.


It has been decided to develop a system to evaluate HEIs based on the implementation of the National Education Policy 2020. The progress made by the HEIs in implementing the NEP 2020 will be considered while granting privileges and entitlements under various UGC Regulations. To facilitate this, a two-step evaluation process has been developed, and specific parameters have been identified to determine the allocation of points. A copy of the document is attached herewith.

## **Grading of Higher Education Institutions (HEI) based on Implementation of National Education Policy (NEP) 2020**

### **Methodology**

Higher Education Institutions may be assessed on the basis of their adoption/implementation of NEP 2020 initiatives. A Higher Education Institution may be required to pass through a two-step process. In the first step, an institution needs to fulfill the mandatory requirements called "qualifiers," followed by "quantifiers," where the HEI will have to reply with "yes" or "no" to a series of questions based on the initiatives of NEP 2020 and the UGC Regulations. The assessment will be based on the data/evidence to be submitted by the HEI. Submission of false evidence and or any wrong declaration by HEI will lead to the rejection of the application and any other action as deemed fit by the UGC.

The two-step evaluation is as follows:

1. Eligibility Qualifiers: These will be the mandatory benchmarks that an HEI needs to fulfill in order to become eligible for the grant of privileges/entitlements.
2. Quantifier Parameters: The eligible HEI will be evaluated on the identified parameters and the grant of privilege/entitlement will be determined on the basis of the points obtained by the HEI.

### **Eligibility Qualifiers**

An HEI shall be mandatorily required to attain the qualifier benchmarks to become eligible for submission of an application to obtain a privilege or entitlement to be granted or conferred by the UGC. HEI will be required to submit evidence in support of achieving a benchmark parameter. The following eligibility qualifiers are recommended:

1. Recognition under section 2(f) of the UGC Act
2. Registration on the AISHE portal
3. Valid Accreditation from NAAC
4. Implementation of UGC guidelines on Public Self-Disclosure
5. Appointment of Ombudsperson and constitution of Students Grievances Redressal Committee (SGRC) in case of a university or deemed to be a university and Constitution of Students Grievances Redressal Committee (SGRC) in case of a college as prescribed in UGC Regulations.
6. Implementation of extant UGC Fee refund policy
7. Constitution of the Internal Complaints Committee (ICC) for matters related to sexual harassment
8. Registration on the portal for Undertaking Transformative Strategies and Actions In Higher Education (UTSAH)

9. Registration on Academic Bank of Credits (ABC) by eligible Institutions (Only for Universities and Autonomous Colleges)
10. HEI should not be on any current list of defaulting institutions published by UGC due to failure to comply with the UGC Regulations/Guidelines/Notifications/specific instructions or to provide information solicited by UGC.
11. Timely notification, in accordance with UGC Regulations, of autonomous colleges approved by the UGC (Only for an affiliating university)

### Quantifiers

An HEI fulfilling the eligibility qualifiers will be eligible for further evaluation. A questionnaire, as given in the table below, is suggested where institutions have to say 'yes' or 'no' regarding implementation/adherence to a parameter. The percentage of 'yes' will determine the points obtained by the HEI, which in turn will determine its eligibility to a scheme or privilege/entitlement.

An HEI may be assessed/evaluated using the following parameters:

The above list is indicative and will require updating from time to time. It is, therefore, recommended that additional qualifier and quantifier parameters be added, modified, or deleted by issuing a public notice. Similarly, the points required for granting privileges/entitlements will be decided by the UGC from time to time by issuing a public notice.

An HEI will be required to substantiate its claim by submitting documentary evidence or relevant information. The decision of the UGC on whether an HEI has achieved a particular parameter will be final.

An HEI will be required to provide evidence in support of its claim of achieving a particular parameter and will submit a declaration that the claims and the evidence made/provided by it are correct and that no false claim has been made.

It may also be noted that benchmarks to be achieved by HEIs to attain entitlement and privileges under various regulations may be suitably modified from time to time by issuing a public notice after approval of the Chairman, UGC.
